4) RIGHTS OF THE RELATED PERSON:

Within the scope of Article 11 of the Law, which “regulates the rights of the relevant person”, we would like to remind you that you have the right to learn whether your personal data has been processed, to request information if processed, to learn the purpose of processing and whether it has been used in accordance with its purpose, to learn the third parties to whom it has been transferred domestically or abroad, to request correction if it has been processed incompletely or incorrectly, to request deletion or destruction within the framework of the conditions stipulated in Article 7 of the KVKK, to request notification of correction and deletion operations made to third parties to whom it has been transferred, to object to the emergence of a result against you due to analysis exclusively by automated systems, and to request compensation for damages if you suffer damage due to the processing of your data in violation of the KVKK.

You can personally submit your requests to the relevant unit of our Hospital by filling out and signing the Application Form prepared in accordance with the Law on the Protection of Personal Data on the Başkent University Alanya Application and Research Center Website in accordance with the “Communiqué on the Procedures and Principles of Application to the Data Controller”.
