1) DATA CONTROLLER:

2) PURPOSES OF PROCESSING PERSONAL DATA, CATEGORIES OF PERSONAL DATA TO BE PROCESSED, LEGAL GROUNDS FOR PROCESSING AND METHOD OF COLLECTING PERSONAL DATA:

The purposes, categories and legal processing grounds for your personal data processed by Başkent University Alanya Application and Research Center are presented below in a comparative manner.

Your personal data is processed by automatic and non-automatic means, provided that the physical information and documents received during the process are entered into the system and images are taken with a camera, based on the legal reasons stated above..

3) TO WHOM AND FOR WHAT PURPOSES PERSONAL DATA MAY BE TRANSFERRED:

Your personal data is processed by our hospital.;

- Monitoring and Execution of Legal Affairs,

For the purposes of Providing Information to Authorized Persons, Institutions and Organizations, it can be transferred to authorized public institutions and organizations upon request.

4) RIGHTS OF THE CONCERNED PERSON:

Within the scope of Article 11 of the Law, which “regulates the rights of the relevant person”, we would like to remind you that you have the right to learn whether your personal data has been processed, to request information if processed, to learn the purpose of processing and whether it has been used in accordance with its purpose, to learn the third parties to whom it has been transferred domestically or abroad, to request correction if it has been processed incompletely or incorrectly, to request deletion or destruction within the framework of the conditions stipulated in Article 7 of the KVKK, to request notification of corrections and deletions made to third parties to whom it has been transferred, to object to the emergence of a result against you due to analysis exclusively by automated systems, and to request compensation for damages if you suffer damages due to the processing of your data in violation of the KVKK. You can submit your requests by filling out and signing the Application Form prepared in accordance with the Personal Data Protection Law on the Başkent University Alanya Application and Research Center Website in accordance with the “Communiqué on the Procedures and Principles of Application to the Data Controller”, in person, by post or via registered e-mail to ‘baskentuniversitesi@hs02.kep.tr’ at Saray Mahallesi Yunus Emre Caddesi No:1 07400 Alanya - Antalya.
